- Rule 47** The nomination paper shall be in such form (including but not limited to electronic form) as the Council may from time to time determine and shall be lodged with the Chief Executive Officer not less than 42 days before the annual general meeting.
- Rule 48** The nomination paper shall contain the name of the proposed candidate and the name of each of his nominators and shall state whether or not he is a public accountant.
- Rule 49** The nomination paper shall be signed by the Member proposed for nomination and by 5 Chartered Accountants of Singapore who are eligible to vote at the election.

Such details (and the photograph) shall be included in any ballot sent to Members who are eligible to vote. By providing the biographical details as above mentioned, the candidate shall be deemed to have consented to the disclosure and use of such details and the photograph for the election process and such details may be made publicly available (whether to the Members or otherwise) via notices, ballot, the Institute's website or other appropriate forum.
